

# **Burlington Civic Panel Members**

#### Rob MacIsaac (Co-Chair)

Rob has been Mayor of Burlington since 1997. Since elected, Mayor MacIsaac has been instrumental in bringing a Smart Growth perspective to growth management in Burlington and the GTA. As a member of the Ontario Central Zone Smart Growth Panel, he leads the sub-panel, established by the Minister of Municipal Affairs, to develop a vision and recommendations for a Smart Growth strategy for the zone. In November 2002, that vision, which includes three guiding principles and six cores values, was released for public input.

His leadership ensured several environment programs in the City of Burlington, including the establishment of an environmental management strategy. He founded a Transit Caucus inviting the Mayors of four other GTA municipalities to create a more transit systems. In May 2002, Mayor MacIsaac received a GTA Leadership Award from the Greater Toronto Marketing Alliance. Mayor MacIsaac established a community foundation and hosts an annual charity gala in support of the foundation's work. His annual triathlon event supports the work of Burlington's first hospice, where he has served as Honourary Chair and was instrumental in its development. In June 2002, the Mayor received the Rotary Paul Harris Fellowship Award from the Rotary Club of Burlington North for his work establishing the hospice.

MacIsaac was first elected to Municipal Council in November 1991. He served two terms on Council. Born in 1962, Rob MacIsaac is a lifetime resident of Burlington. He is married to Anne and has two children, Sarah and Catherine. Rob attended the University of Waterloo where he completed his undergraduate degree in Economics in 1984. In 1987, he completed his LLB degree at the University of Western Ontario, and was called to the Bar in 1989.

# Joey Edwardh (Co-Chair and Co-Chair of the Inclusive Cities Canada National Steering Committee)

Dr. Joey Edwardh is Executive Director of Community Development Halton, a research and development organization that serves Halton's nonprofit agencies and community organizations. Community Development Halton has a membership of 100 organizations providing human services to Halton's 375, 000 residents.

Born in Alberta, she studied at Syracuse University in the Maxwell School of Citizenship and Public Affairs, where she earned her doctorate in Human Geography and a Certificate in Gerontology. She also held a National Health and Welfare Canada Post-Doctoral Fellowship to investigate comparative health systems.

Dr. Edwardh's career has been dedicated to work in the area of social and health services, social research, policy analysis and community development both in Canada and internationally, most

recently a 10 year tenure in Santiago, Chile. She has a wealth of experience in a range of service, planning and advocacy organizations that include grass roots community organizations, agencies of the voluntary sector, universities, municipal government and the United Nations. She has written extensively on productive aging, issues of poverty and income equity, the social implications of the privatization of health and social services and the need for a strong and vibrant civil society.

Dr. Edwardh's role as a volunteer in a number of community agencies marks her commitment to her community. She serves on the Advisory Board of CH TV, the Board of Directors of the Centre for Skills Development and Training and until recently was a Director of the Burlington Economic Development Corporation where she chaired their Research and Development Committee. Presently, she is a member of the Regional Diversity Committee, a body that is attempting to grapple with the challenges of growing diversity throughout Halton's communities. At the provincial level, Dr. Edwardh is a director of the Social Planning Council Network of Ontario

#### Rick Craven
